




MISCELLANEOUS ORDER

Pursuant to Local Rule 4.04, all parties in any suit involving the parent-child relationship brought under Subtitle B of Title 5, Texas Family Code, including but not limited to suits for divorce joined with parent-child relationship suits, but excluding uncontested suits for termination and adoption, shall attend and successfully complete a children's interest seminar prior to the final hearing unless written waiver is obtained from the Court. Further, parties in a suit affecting the parent-child relationship with children ages of 6 through 17 shall have their children attend and successfully complete a seminar that is designed to aid children to cope with the effects of such a suit.

The Clerks of the Court shall provide to each attorney or pro se party upon the filing of their initial pleadings in such a suit, a copy of this Order and an informational sheet concerning such seminars.


